

DIGITAL PUBLICATION END-USER LICENSE AGREEMENT (EULA)

IMPORTANT – READ CAREFULLY: This Digital Publication Font License Agreement (the “Agreement”) is a legal contract between you (“Licensee”) and Thistle Type (“Licensor”) governing the use of the Font Software identified in your purchase (the “Font”).

By downloading, installing, or using the Font, you acknowledge and agree to be bound by this Agreement. If you do not agree to the terms, you must not use the Font.

Definition of Font

The term “Font” refers to the digital typeface software, including all styles, weights, character sets, file formats, and any updates or modified versions provided by the Licensor.

Grant of Licence

Subject to the terms of this Agreement, the Licensor grants you a perpetual, non-exclusive, non-transferable licence to embed the Font in digital documents such as eBooks, ePubs, PDFs, and other digital publications that contain live, selectable text. This licence covers one (1) title per purchase. Each additional title or publication requires a separate licence. You may produce and distribute an unlimited number of copies of the licensed title, provided the Font is embedded in accordance with the terms below.

Permitted Use

Under this licence, you may:

- Embed the Font in a single digital publication (eBook, ePub, interactive PDF, or similar format) that includes live, selectable text.
- Distribute the publication on any number of platforms or marketplaces (e.g., Amazon Kindle, Apple Books, Google Play Books), provided it remains the same title.
- Embed the Font in a secure, read-only manner (e.g., subset embedding) that prevents extraction or reuse of the Font.
- Use the Font to create cover artwork, promotional graphics, or marketing materials for the same title.

Restrictions

This licence does not permit the following:

- Embedding the Font in more than one title or publication.
- Embedding or using the Font in applications, websites, apps, broadcasts, templates, or other products beyond digital documents.
- Allowing end users to extract, download, or reuse the Font from the publication.
- Modifying, adapting, reverse-engineering, or creating derivative works of the Font, except as necessary for file format conversion required by the publishing platform.
- Redistributing, reselling, sublicensing, or otherwise providing the Font on its own, or as part of any asset library, tool, or editable product.

Third-Party Usage

This licence is granted to you as the Licensee. Third parties (e.g., publishers, designers, or formatters) may use the Font only to prepare the licensed title on your behalf, and only under your direction. They must delete the Font from their systems upon completion of the project.

AI Usage

You are expressly prohibited from:

- Uploading the Font or its character designs to AI or machine learning platforms.
- Using the Font to train, enhance, or prompt any AI or generative system.
- Allowing AI tools to analyse or reproduce the Font's style or structure.

Any such use constitutes a material breach and voids this Agreement.

Updates and Upgrades

All future updates or upgrades to the Font provided by Thistle Type are included in this license at no additional cost, unless explicitly stated otherwise.

Intellectual Property

The Font is protected by copyright and other intellectual property laws. All rights are reserved by the Licensor. This licence does not transfer ownership. You may not claim the Font or any derivative as your own.

Backups

You may make one (1) backup copy of the Font for archival purposes only. This backup may not be installed or used on additional devices or by anyone other than the original owner.

Licence Compliance

The Licensor reserves the right to request reasonable documentation (e.g., purchase records) to verify compliance with this licence.

Termination

This Agreement will terminate automatically if you violate its terms. Upon termination, you must delete all copies of the Font from all devices and backups.

Warranties and Liability

The Font is provided “as is” with no warranties, express or implied. The Licensor shall not be liable for any damages resulting from its use or misuse, including lost profits, business interruption, or data loss.

Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of Scotland and the applicable laws of the United Kingdom. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the Scottish courts.

Entire Agreement

This Agreement constitutes the complete and exclusive understanding between you and the Licensor, superseding any prior or existing agreements, communications, or understandings.
